Objective description	To describe the foundations of the clinical mental health counseling profession.
Method of assessment	Midterm and Final Exam in CGPS 769; Counselor Preparation Comprehensive Exam (CPCE).
Goal for assessment results	Students will successfully pass the Midterm and Final exams in CGPS 769 with at least a "B" average. Students will successfully complete the CPCE by scoring within one standard deviation below the mean overall.
Data and/or evidence	Eleven students took and passed both the Midterm and Final Exam in CGPS 769 in the Fall of 2019. The mean score for the midterm was 96.72% with the lowest score being 83.33%. The mean score for the final exam was 90.44% with the lowest score being an 83.33%. Thirteen students took the CPCE in the Spring 2020. Of those 13 students, one failed the overall score and had to remediate by taking the CPCE or National Counseling Exam (NCE) and passing that. The student chose to take the NCE exam and passed that in July 2020. The mean score of the CPCE on the first exam attempt for NSU students was 84.70. The overall score on the CPCE for all programs using the CPCE as an exit exam was 84.39 with a standard deviation of 13.51, making our mean 0.31 points above the mean.

## Summary of strengths and/or areas for improvement

Overall, the goals of the program were met. Students passed all required courses with a "B" or better average. Students did very well on the assignments in the courses, averaging 90% + on all assignments and tests. The only goal that was partially met was knowing the foundations of the clinical mental health field, as assessed by the CPCE exam. Students largely passed the CPCE on the first exam (12/13 students). He passed the NCE exam as a substitution for the

CPCE in July 2020. Enrollment in the CMH Counseling Program is slightly increased from last year. Significant efforts continue to increase enrollment in the CMH program.
